The construction will be based on a project plan to be agreed with the Contractor to follow this PC meeting with the go live date of 31<sup>st</sup> January 2021.

  - To ask Barwick in Bloom to take over the maintenance of the Planters and an annual sum of £100 be made available for replacement planting
  - To agree to replace the fencing and gate alongside the Verity Strip and to delegate to the Finance and General Purposes Committee authority to agree a specification, seek tenders, appoint a contractor and complete the work. A budget of £10,000 plus VAT be allocated for this work.
  - To agree the recommendations of the Allotment subcommittee regarding the location of a Container for use by Barwick in Bloom at Barwick Allotments subject to the group obtaining planning permission.
