 - That the consent of Leeds City Council (LCC) be sought for the installation of two Speed Indicator Devices (SIDs) of the smiley/sad face variety in Barwick, one on the entry point to the village from Garforth (Long Lane) and the other on the entry point to the village from Scholes (Leeds Road). (To be paid for by this Parish Council).

- That a request for the SIDs already in place in Scholes be serviced by LCC and the effectiveness of these SIDs be reviewed in 2022.
- That the proposed 20 miles per hour speed limits be taken up with LCC.
