- To note progress on the proposal to use a single contractor for all hedge cutting requirements in the Parish and that five clubs (both cricket clubs, Scouts, Village Hall and Scholes Bowling Club) would be willing to be considered.
- To note the decision of the Parish Council to agree replacement of the fencing and gate alongside the Verity Strip and that this has been delegated to the Committee to agree a specification, seek tenders, appoint a contractor and complete the work within the agreed budget of £10,000 plus VAT and to consider the fence by the Pavilion.
